Signs have been placed there due to the excessive number of cars parking on the side of the road impeding the flow of traffic. The selectmen will review the area to see if there is a way for the White Mountain National Forest Service to put in a parking area for hikers. If not, maybe some parking can be made available along the town's right of way in that area.
