Meeting opened at 03:35 PM.

Scott Grant, School Board Liaison, mentioned that NH Department of Environmental Service has come up with some new rules which are a state mandate concerning oil tanks at schools. The oil tanks/lines were inspected by an engineer and ours don't meet code. It is going to cost between 15-22 thousand to bring them into compliance. Chairman Chandler asked if we could get a copy of the letter. Grant will see that we get a copy. Grant has been able to put them off until April.

Grant thanked the highway department for the nice job they have done plowing the school yard and inquired if before the school and town meetings if they could widen out the yard. Chairman Chandler replied that he will ask the highway department to do that.

Grant also mentioned that there is a school board meeting tomorrow night that will be discussing having a preschool for ages 2-4 at the Bartlett school. Grant is in favor of education but not preschool.

Ed O'Neil of Washington Street stopped by to check on his building permit for a house. There was missing information and a letter was given to O'Neil.

The Selectmen discussed that town election would be on Tuesday, March 13, 2018. Town meeting will be Tuesday, March 20, 2018 and school meeting is Tuesday, March 6, 2018.

The town budget hearing will be February 14, 2018 at 06:30 PM.

Police Chief Christopher Keaton popped in and informed the Selectmen that the two candidates for the police officer position have both passed their physical agility tests and he is now doing the background checks on them. One is from Madison and the other one from Meredith (she is planning on moving closer after she completes the academy).

The Selectmen signed checks, reviewed building permits and correspondence throughout the meeting.

The Selectmen will not be meeting on January 15, 2018.
